- 3. LOCAL Legislative/Regulatory Updates/Discussion (All-5min)
  - a. Charlotte, Raleigh, Other? Mayor of Charlotte said no referendum. So no Transportation funding.
    - i. TCC Issues with Water Allocation Policies, Funding, and
    - ii. East expansion of permitted discharges to swamp waters. Limits utilities ability to modify discharge Wilson, New Bern, Cherry Point. Will conflict with Interstate expansion on the 70 corridor. DEQ is waiting on lower Neuse model. Not caught Legislators yet. Humphreys, Reader...maybe need to be packaged to them. Implications to their Districts.
- 4. STATE Legislative/Regulatory Updates/Discussion (Brock/Tara/David-15min)
  - a. NC Bills potential bills/status Agency Bill/Bond NCDOT agency bill based the House and sitting in Transportation Committee. Concerns with part of bill. Senate wanted to wait until the Short Session. NCDOT stated their concerns on timing. David will follow up with Leaders to understand an important issue for us and get this pass whether in the Agency Bill.
    - i. If get it passed by June 1. Sell bonds by Nov 1 and issued by end of the year. Changes the cash floor that NCDOT has to maintain as well. David will determine if this is a major issue for NCDOT...need to figure out why the concerns and do that much before the session.



- ii. \$300M in projects being delayed but will move forward. Haven't heard that this bill will affect Operations.
- iii. Jenny to reach out to Mike Holder who has had conversations with NCDOT.
- iv. Tara mentioned meeting with Secretary and Mike Holder on the 12<sup>th</sup>. Move information to come. Will coordinate with David Ferrell.
- v. Not a lot of new policy in the Short Session.
- b. Budget not a lot of new money. Focus on water/sewer infrastructure. Cleaning up bills from last year that didn't get passed.
- c. David will continue to report on happenings.
