

ADVOCACY UPDATE Transportation Funding included in State Budget

In a huge WIN for the transportation industry, the General Assembly has included the provisions of SB 793-Transfer of Sales Tax Revenue from General Fund to Highway Fund in the 2022 Appropriations Act, approved July 1. Beginning in Fiscal Year (FY) 2022-23, starting in July 2022, the 2% transfer is estimated at \$192M), and by FY 2024-25, the 6% is estimated to be \$628.3M based on 2022 projections. The Appropriations Act was approved



by both chambers by bipartisan votes and was signed by Governor Cooper on July 11!

A huge thank you to everyone who attended our Legislative Day and advocated for this to happen for months, as did our related industry partners. Our friends in the legislature worked tirelessly on this, so please thank them. This is a great first step in the program to transition transportation funding from the Motor Fuels Tax to other long-term sustainable revenue streams.
